### **PROJECT BRIEF**

Council is seeking expressions of interests from suitably experienced Wollondilly Based Community Groups or Charities to provide a Community BBQ for Australia Day 2024.

The Australia Day Community BBQ will comprise of:

- **BBQ** Breakfast - Bacon & Egg Rolls
- BBQ Sausage Sizzle Sausages on rolls / sliced bread
  - Vegetable Patties on rolls
- Coffee / Tea and Lamington station

The Australia Day Community BBQ and Coffee /Tea Station will be held between the hours of 8am until 12pm.

Council will provide a financial contribution of \$1,000.00 to the successful community group or charity. The successful community group or charity may also collect (voluntary) gold coin donations from the Australia Day Community BBQ.

Additional to the financial contribution Council will provide the following:

- BBQ Meat, sausages, bacon
- Eggs
- Bread Rolls / Gluten free bread
- Onions
- Condiments

- Vegetable Patties
- Coffee, tea, sugar
- Milk.
- Lamingtons
- Ice

- **Trestle Tables**

### DESIRED OUTCOMES FOR THE COMMUNITY 1.1

- Enhanced community participation through the provision of a free community BBQ to celebrate Australia a) Day to foster social connections, community cohesion, and a sense of belonging.
- Promote local participation by supporting eligible community groups to actively participate in local events b) contributing to a vibrant and inclusive community.

### 1.2 REQUIRED DELIVERABLES BY COMMUNITY GROUP OR CHARITY

- Provision of a free Australia Day Community BBQ and Coffee / Tea Station. a)
- Provision of volunteer labour please note this is an extremely busy BBQ serving on average 2000+ b) people, appropriate numbers of volunteers will be required to cook, serve and maintain health standards.
- Provision of BBQs and associated resources c)
- d) Compliance with Australian Food Handling Safety and associated Health Requirements
- Current Public Liability Insurance coverage / Volunteer Insurance / Workers Compensation (if applicable) e)

#### 1.3 **EVENTTIMEFRAME**

The Australia Day Community BBQ and Coffee / Tea Station is to be delivered to members of the public attending the Wollondilly Australia Day event on 26 January 2024 at the Picton Botanic Gardens / Hume Oval between the hours of 8.00am and 12.00pm.

Set up and pack down of the site is to occur prior to and following the hours of 8.00am and 12.00pm.

### **SUMMARY OF REQUIREMENTS**

To respond to this EOI, a Responding Community Organisation or Charity must:

- a) Complete the Expression of Interest form
- Attach to the Expression of Interest form all items listed in Clause 2.1 b)
- c) Sign the Expression of Interest form,
- d) Lodge the Expression of Interest in accordance with Clause 2.2

#### 2.1 **ASSESSMENT CRITERIA**

Proposals will be determined against the following assessment criteria:

- a) Capacity to provide voluntary labour and relevant equipment / resources – state the number of volunteers and resources to be provided by the Community Group / Charity
- Applicants experience in providing a Community BBQ b)
- Current Public Liability Insurance coverage / Volunteer Insurance / Workers Compensation (if applicable) C)
- d) Compliance with Australian Food Handling and Health Requirements
- Identified local community benefit, how will the funds raised be spent? e)

#### 2.2 LODGEMENT OF EXPRESSIONS OF INTEREST

Expressions of Interests should be marked 'Australia Day Community BBQ' - Response to EOI' and will only be accepted by email to events@wollondilly.nsw.gov.au.

Expressions of Interests must be submitted, in accordance with the requirements set out in this EOI prior to 5pm Friday 24 November 2023.

#### 2.3 CONFIDENTIALITY

Information provided in this document or imparted to any Responding Organisation as part of the Expressions of Interest process is confidential to Council and must not be used by the Responding Organisation for any other purpose, or distributed to, or shared with any other person or organisation. Information supplied by a Responding Organisation shall not be treated as commercially confidential unless specifically requested by the Responding Organisation.

#### 2.4 ANNOUNCEMENT OF THE EXPRESSIONS OF INTEREST

Council will notify the responding organisation via email of the outcome of the Expression of Interest.

Council may provide reasons for the choice of the Successful Organisation if formally requested in writing by a Responding Organisation. Unsuccessful Organisations are not entitled to otherwise seek to challenge or question the validity of the determination made by Council.
