Hi There,

Thank you for the chance to put forward my views on the special adjustment in the rates.

Firstly, how has this happened? I watch development happen and we the residents are continually disadvantaged. These include, the removal of overtaking lanes to provide access to Wollondilly Anglican School, Bingara gorge and the new flour factory along with poorly designed roundabouts at many other places.

With the growth of traffic these changes and the continual neglect of the shires roads, it is taking longer and longer to get to work or to shopping. These include, turning right into Picton from the M5, where the increasing amount of Wollongong traffic wants to turn right on to the northbound entrance of the freeway. The increasing amount of traffic travelling south from Camden via Woodbridge road to avoid Narellan Rd and the never happening repairs of Remembrance Drive over Razorback.

Secondly, all the time I see poor work done, that quickly deteriorates. I spend hours cleaning off the tar sprayed from your patch truck. In some places the whole road is made up of these repairs, that quickly breakup with trucks after rain. Thirlmere Way, over the hill near the hospital is another example. It took at least three attempts to get this right and it is little better than before it was resurfaced.

St, where I live, had the edges graded last year. The grader, damaged the edge of the tarmac on this already narrowing road. This has been further compromised by school buses and other heavy vehicles that now move on to the road edge to pass other vehicles. This year, some less than bright person came along with a machine and a mulcher that pushed all the dirt back on to the road verge as well as leaving behind a heap of dead timber that will be dry enough to burn this summer.

Well, I could recall a few more, but hopefully I have made my point. I don't think you always spend money well or in the best interest of residents.

To meet the Governments "Fit for the Future", I suggest;

- 1. Large parts of the council lands are cut off by the Warragamba Dam and are not going to be economic sustainable. Move these to a more appropriate council.
- 2. Reduce the services offered.
- a) Many small parks are not really used, would be better sold off and developed for example, Bell Street, Thirlmere.
- b) Remove Library services. No different to privatising the pool.
- c) Replace council cleanup with 2 by annual tip passes.
- d) Cost recovery for usage of sports grounds and facilities.
- 3. Focus on roads, residents and the townships that make up this shire.

4. Ensure new housing and industrial developments pay their way and limit the impact on current residents.

In conclusion, with an increase in housing costs, many more people are going to be looking for cheaper housing options in this area. Areas around stations need to be rezoned to a higher density. Sadly the changes needed will negate the reasons most people moved here in the first place. Already I have seen the town of Tahmoor change from a friendly place to just another suburb. With councils current attitude to road repair and upgrades along with the delivery of outdated services, even with an increased levy, this is not going to be enough to provide residents with a sustainable place to live.

### Efficiency

- In terms of efficiency I would like to know the breakdown of expenses that go to "soft services" and to administration and to direct expenditures
- 2. You mention "resource sharing with other councils". Would we be better served by amalgamation with adjacent councils?
- Consider the provision of less sophisticated services and more modest designs for bridges and the like

### Rates

- 1. The disparity in your numbers between Camden and Wollondilly is marked. Why is that? Is it that the rates are double us? If not what are the other revenue streams do they have? Can Wollondilly attract such streams?
- 2. Are rate incentives used to attract businesses to the shire?
- 3. As always, it is about allocation. Visible works whilst nice it should be the council's primary responsibility to create "community". More difficult less tangible but essential.

### Dear Sir/Madam

It was with horror that I read that expensive pamphlet you sent every household. How much did that cost? It would have been better spent on infrastructure.

When I purchased my home here the rates were already high enough. But nearly every year we get hit with enormous rate slugs to a point where our rates are over \$1700 pa. This is already too large a slug for the average household which is struggling to cope financially with the 'money grabs' from all directions . We are all struggling to cope as it is – let alone with your over 43% slug over 4 yrs – under the guise of having to do it to maintain infrastructure.

Councils already get more than enough to not only maintain but should have enough from the \$1700pa plus per household and from other sources of subsidy and revenue to do this. If anything rates should be reduced. Follow the lead of the State and Fed Govts in trimming your own bureaucratic and over administered organisation eg. lower wages for staff esp the mayor and other high level managers, cut the fat from procedures and reduce staff and admin expenses. IF that is unpalatable then you should consider amalgamating with adjoining councils or aboloshing local councils altogether. Don't feel insulted by these suggestions . They are factually more sensible and able to achieve better infrastructure outcomes than your 'money grab' from the same old cash cow your poor ratepayers.

Stop this nonsense now or face being voted out next election. Other residents all say the same thing. Give us a break and don't blame the State Govt.

I refer to the recent request for feedback on council proposed 'Special Rate Variation'.





The 20 year programme will be Shire wide said Cr Banasik then Councillor/s came up with a seven years compounded rate rise costing us a lot more, we end up with a single driven truck that drives over pot holes dropping a little dab will do you done so many times in areas making the driving rough going and some bad patches done by a crew, the SHIRE WIDE 20 year programme has ended up a furphy OUR SHIRES ROADS ARE DESPERATE.

Number 2 newspaper article 2005 as attached headline, MAYOR BACKS RATES AS 'COMPROMISE' thus reduced to 6.7% rate rise recommended for 7 years long instead with added compound interest rates hurting the rate paying Public even further was carried out.

I AM SAYING NO TO A FURTHER RATE RISE UNTIL ALL THE SHIRE 'S ROADS GET A VERY LONG AWAITED ROAD SEAL, 25 YEARS it appears years is far too long, we have been so neglected in comparison to CAMDEN COUNCIL stretching through to Leppington many off roads it appears, handling high density traffic, so with Wollondilly Shire re-considering rural status I say no until ratepayers get much needed infrastructure and can feel the roads are safely maintained re-sealed is now a priority. Please assist in encouraging Wollondilly Shire Council to address the rate-payers needs as mentioned.



Freeze any rate rise till this has come to pass and further infrastructure in place.



### Special rate rise on the table

To keep up with the infrastructure backlog, Wollondilly residents are being asked to support another special rates variation.


With only weeks into the top job as the shire's general manager, Luke Johnson isn't slowing down to smell the roses, but rather has clear sight of the backlog of works piling up. Mr Johnson is asking for a rate special variation - similar to what his predecessor has done before; he believes it's only way in sustaining what the local government area has.

"There's approximately \$15.8 million worth of infrastructure backlog; how we go about addressing the issue is to have a conversation with the community, which is so important," Mr Johnson said.

There are three options being proposed the first is the do nothing scenario where the annual automatic three per cent rate peg is passed and existing infrastructure such as roads, parks, sportsgrounds, bridges and halls will be left to continue to deteriorate.

Option 2 looks at "stabilising" what is already with 8.5 per cent annual increase over four years (including the rate peg) - this will provide some additional funds as well as new infrastructure.

Option 3 is about "improving" what's in the shire and would include a 10.8 per cent annual increase over four years (plus the rate peg) - this will allow more available funds for

# Please seal these roads: residents

### SHAUN DAVIES

RESIDENTS of a small area at Buxton say emergency service workers cannot access their homes because Wollondilly Council will not take responsibility for their unsealed roads.

The residents of Beverly and Belair roads said they also suffered flat tyres and damage to their cars due to the rough conditions, despite almost all of them owning four-wheel drives.

Garbage trucks do not come down the two roads. The residents either drag their bins several hundred metres to the nearest council road, or take their garbage to the tip.

The "unformed roads" were graded several months ago with emergency council funds after heavy rain, but the residents said their condition was deteriorating.

The council is now considering taking responsibility for the roads, after Councillor Shane Read and acting director technical services Charles Dunlop visited the residents.

One resident, Helen Rutherford, said police who were called to Belair Rd earlier this year were forced to stop their car at the top of the road and walk down.

She said fire officers had told her they would not be able to get trucks to her house, at the very end of Beverly Rd, in the event of a bushfire. Bushfires threatened the area in 2001. Another resident, Julie Lofts, said she did not bother calling an ambulance when she suffered a near-fatal anaphylactic shock last year. "My husband had to rush me to hospital and there's no way you can get an ambulance in here because they won't come down this road," Mrs Lofts said. "The roads aren't even on the maps."

Wollondilly Mayor Phillip Costa said the roads were never intended to be built. He said fixing the roads would be an expensive exercise. "But we're now in the 21st century and I agree that we should look at those roads and see what can be done," Cr Costa said.

Cr Read, who raised the issue at last week's council meeting, said he wanted to see the roads tarred and the residents granted council services.



I am appalled and deeply concerned about the council's move to increase rate charges.


There are many long term, older residents in the Wollondilly area who will be adversely affected by an increase in rates.

I wanted to come down last week to talk about our rates but unfortunately I had a bad cold.



### In Response to Special Rate Variation Document.

Thank you for giving me, as a rate payer of the Wollondilly Shire, the opportunity to comment on this document.

As with all businesses, of which Wollondilly Shire Council is one, it is necessary to come to terms with the financial situation of the business. At the end of the day, the desirable situation for all businesses is to be in profit. It is very obvious that the Wollondilly Shire Council is NOT in profit otherwise there would not be the necessity to take action.

Therefore something must be done. There are only two options available.

1. To have a Special Rate Variation

OR

2. Borrow the money.

Both the above options have short and long term effects in relation to the immediate needs. The second is not a feasible option due to long term financial effects.

As stated in the document, we the ratepayers, have been offered three options.

Option 1 Deteriorate Option 2 Stabilise Option 3 Improve

Something has to be done in the short term to deter the collapse and deterioration of the infrastructure but the Wollondilly Shire Council has to look to the long term

In the words of a former NSW Premier Arthur Calwell, "Populate or Perish" it is evident that by the statistics provided in the brochure in regards to population compared with surrounding metropolitan councils, Wollondilly Shire is by far the least populated.

Council may argue that there is a foreseeable population growth over the next 20 years but the need is immediate and if the infrastructure is not repaired and maintained now there will be nothing to encourage the growth of Sydney's population to move to the Wollondilly Shire and make it their home.

If the Wollondilly Shire Council is to maintain and improve the infrastructure of the shire it is imperative to increase the population thus increasing the revenue per capita and this can only be done by making provision for sub-division of larger acreages and therefore create more building sites which will in turn increase the population.

With an area of over 2500 sq kms in the Wollondilly Shire it is not feasible from a financial point of view to support a population of only 45.322. It is all very well for council to envisage a "Rural Living" lifestyle but

when it comes to maintaining roads, bridges, buildings, parks, halls, libraries and the like this is unsustainable. Not only does the population growth of the area need to be addressed but also the economic development of the shire through retail, tourism and industry by supporting these three facets of growth.

### The re-introduction of Progress Associations.

Local Progress Associations unite the community to develop pride and passion for one's locality by providing a positive approach to the improvement of the local area. Members work together for the common good to improve facilities such as parks, gardens and halls. They also provide a social aspect for the community to get to know their neighbours and provide input and information to the community on local affairs.

Progress Associations also give the community the opportunity to approach council on issues of concern that have been discussed at length and decisions have been reached unanimously thus providing well researched information to the council. Many Progress Associations raise money to improve facilities in their area and thus assist council financially.

### Accountability.

The Wollondilly Shire Council will need to be accountable to the ratepayers of Wollondilly Shire in that the monies collected from Special Rate Variation is used for the intended purpose ie. repairs, maintenance and improvement of infrastructure and not put into the general coffers to be absorbed into the general management of the Wollondilly Shire Council.

A report should be tabulated stating the extra money collected from the Special Rate Variation Scheme and where the money has been utilised. This report should then be distributed to the ratepayers of Wollondilly Shire on a pre-determined regular basis to enable the ratepayers to know exactly where the money has been spent.

### Quality of Work Undertaken.

This is an extremely important factor in the spending of finances. Short term fixes are not viable or sustainable ie filling pot holes. A programme of works should be drawn up in order of priority with estimated quotes and time span for completion for the work This work should be undertaken at the highest quality and be looked upon as preventative maintenance and not a "short fix" This programme of work should be advertised or distributed to the ratepayers.

### Seeking Expert Advice.

As Local Government is an arm of the State Government has the Wollondilly Shire Council sought input and advice from the New South State Government in order to solve the financial crisis the Wollondilly Shire Council finds itself in?

They may in turn have another solution to the crisis other than leaning on the ratepayers to come to the rescue of the Wollondilly Shire Council.

Over the years there have been rumors that the Wollondilly Shire was going to amalgamate with Camden and Campbelltown to form a Macarthur Shire or on the other hand with Wingecarribee to form a Southern Highlands Shire Council. Could these scenarios be an option to solve the financial crisis?

The ratepayers of Wollondilly Shire should be better informed as to how the Wollondilly Shire has taken so long to inform us of the predicament they find themselves in and how this has come about before requesting us to make decisions on how to solve the problem if in fact it is a solution.

At this stage I am not prepared to support any of the options until I receive more information in relation to the queries in this email

We write regarding the Special Rate Variation currently under consideration by Wollondilly Shire Council.

I strongly object to any further SRV for the following reasons:-

- 1. The current rates payable to Wollondilly Shire Council are already rather excessive for the services provided. Having resided in other NSW LGA's, the rates payable here for the quality of services provided are considered poor.
- 2. Whilst it is understood that the land area covered by the Wollondilly LGA is expansive, the burden to maintain such a wide network of roads should not continually rest with the small number of residents. Why did Campbelltown Council receive \$1.4m more in funding than Wollondilly given Wollondilly are required to maintain a far greater network of road infrastructure???
- 3. As residents of Bingara Gorge, in addition to rates payable to WSC, we are already funding the maintenance of parks, gardens and streetscape through our Community Levies. Community title estates are essentially a requirement of Council to relieve the cost burden of additional maintenance of these open spaces within new estates. If the SRV proceeds, special consideration should be given to exempting those Community Title areas given the circumstances already imposed upon them. The only thing Council currently provide for us is a garbage collection service they don't maintain our parks, gardens, streetscapes or roads.
- 4. Perhaps Council can consider other income generation options such as a review and disposal of their excess land holdings. Other Councils in NSW have successfully implemented such a review process of land holdings and generated substantial income from the sale/lease of excess land. As a ratepayer, it would be appreciated if before taking the easy option of placing the burden on the ratepayers by increasing rates, other options are also considered?

The previous SRV yielded little for the residents of Warragamba/Silverdale and I do not want to pay increased rates for the benefit of other sections of the shire that I do not access.



My comments are as follows ....

Fully understanding that infrastructure requires maintaining, however the current rates of \$1364 for our small property at appear to be already quite high for a small townhouse. Add the fact that annual salary increases in certain industries (especially the manufacturing industry) have been adjusted upwards only once during the past 3 years (by 3%) - with no salary adjustment this year - then it is not possible to see how one could afford such a special rate variation - with many other costs increasing at the same time.

As salaries remain stable, with less disposable income, we are forced to be more careful with our weekly purchases regarding where and what we purchase. More bang for the remaining bucks if you like.

I would like to see councils doing more in the same vein - amalgamation of councils, more streamlined processes, staffing reviews, efficiency improvements and so on. Understanding that maximisation of efficiencies is key to the solution - but no figures have been shown which clearly state savings made year on year. For instance how have operating costs been reduced during the last financial year, and what plans does council have to reduce costs even further? Why is Camden's revenue so high when compared against Wollondilly? Why not amalgamate Camden /Wollondilly - which would still be for a population of just over 100k - and reduce staffing, sell excess council property that has been made redundant by the amalgamation, and so on.

Hopefully the 'Fit for the Future' requirements will address much of this ....

As such it is my recommendation that there should be no special rate variation until there is more clarity regarding actual savings year on year, and future forecast savings year on year based on implementation of current plans. 'Fit for the future' may well address these concerns ...

Re: Gentlemen,
I am in receipt of a Council request to support increases to rates over the next few years and this has compelled me to again write to Council regarding a situation in Camden Park that has not been addressed by Council.
I am a resident in an analysis and my property is adjacent to a reserve that was used for some years to house a container holding landscaping equipment for use in the estate at the direction of Stockland.
When this container was delivered to the reserve it was deemed necessary to drop road base on the grass at the entrance to the container and up to the roadway, (approximately 10.0 x 3.0 metres) as a means of containing any mud when accessing the equipment during wet weather, this was done by either Council or Stockland and although the container has been moved some time ago the condition of the reserve is still dreadful.
I and other residents in have had visits from Councils environment personnel on occasions and we have pointed this situation out to them over the past couple of years and nothing has been done by either Council or Stockland to recuperate the reserve to what it should be and was originally.
I am fully aware of the increasing costs of upkeep to Council property and also the cost of servicing needs of ratepayers however this situation was bought about by Council not ensuring that the developer repaired and or maintained this area to what it should be and that is why I am reluctant to support any increases to rates.
I believe that Stockland should be responsible for the removal of this road base and the regeneration of grass to the area in question and I ask that Council request that this be done as a matter of urgency as it is highly probable that an injury or damage will occur due to the rocks being thrown around when mowers are used in the reserve.

Dear Sir/Madam,

When asked, all residents – rate payers and non-rate payers – will agree that the Shire's infrastructure, and in particular the road network, needs to be of a high standard.

However, this can hardly be taken as justification for an (almost) perpetual application for a Special Rate Variation.

When this S.R.V. principle was first raised some years ago, the clear impression that was given was that this was of a temporary nature to help overcome a budget shortfall. However, as has become obvious, at the end of the designated period, the compound rate rises have become part of the base rate.

Now, once again, a major shortfall of \$80 million is being projected for the next ten years, and once again only another S.R.V. of no less than 10.8% compound for 4 years is put forward as the solution to all problems.

Ironically, thus achieving a massive overall rate increase of around 50% over 4 years, Council then reassures us rate payers that "at the end of the four year period the S.R.V. increase will be built into the rate base".

This is bureaucratic double-speak for"the total 50% increase will form the new base rate from then on". Undoubtedly to be followed by another S.R.V. for the remaining 6 years.

Everyone, including rate payers, have to live within their means.

Council, as a Government entity however, only considers an increase in their "means" by shifting the burden onto rate payers.

There are limits to the financial capacity of rate payers.

It would therefore be reasonable for Council to show what sacrifices it is planning to make itself as a contribution and/or what additional contributions have been sought from State or Federal Government to enable Council to deal adequately with what it considers" exceptionally high infrastructure costs, relative to a small rate base".

These S.R.V.'s can not possibly be loaded onto rate payers year after year.

I am witting to express our concerns re the proposed rates increase that will be above the normal pegged 3% increases that you have outlined in your "Fit for the Future" post out brochure. As you will read below we believe that you will do Wollondilly harm, not good, by your proposal.

- We reside in the beautiful village of Douglas Park, we have seen no improvements in or around our street for for the past 9 years that we have lived here so we are very much opposed to any increases in our rates especially when we have the fear that we will still see no improvements even after the increases.
- Being pensioners we will find it very difficult to pay the proposed increases in the rates, we are not a bottomless pit for funds, you can't keep reaching into our pockets like this.
- We believe that the population in Wollondilly will steadily increase naturally as people
  realise what a great area it is to live in thus with new residences & estates being
  constructed council will be receiving more income in new rates collections which will be
  a plus as council has minimal outlay for these estates as it makes the developers pay for
  the infrastructures required with establishing new estates and council will be seeing more
  funds coming in from new rates collections.
- We already pay for waste collections in our rates so there is no burden on council for the
  picking up of our bins etc and more revenue will come when new residences are
  established.
- For the rates that we already pay we see no services or maintenance in our street, probably because our end of the street is zoned as rural for which we are already penalised by the lack of services already, we don't want to have to pay for an increase in rates and still receive no services.

We would like to say that as a long time resident of Silverdale that we are not happy with the proposed increase in council rates.

The information pamphlet reached our home only the day before the community information meeting was to be held. No forward planning there.

We feel that our area has been somewhat 'hung out to dry' with all the surrounding development and airport approval. How will this affect our area? No consultation or information has been forthcoming and our 'Rural living, room to grow' will soon be gone with planes buzzing overhead, noise and pollution.

Residents have chosen this country lifestyle simply by moving here and we have always put up with substandard services by the council for this privilege. We have never had adequate medical, dental, aged care, mental health care or transport in the area. After many trips around the country, we can assure you that Silverdale rd is by far the worst road we have come across. We have no paths to even walk to the local shops, with big drop offs on the side of the gravel road making it both dangerous for vehicles and pedestrians alike. 



This is classified as Rural Residential, how is it that truck companies are allowed to operate? There is going to be a serious accident soon, but then it will be too late.



Good afternoon

After many years in I feel that I need to address this issue.

I understand the logic of your argument. However continually throwing money at a problem is not the answer. While rates can spiral upwards, thereby providing more capital to 'play with', in the long term this will not address the core problem. It is about how the money is allocated and spent. There is a demonstrable need for greater strategic thought and accountability.

For many years Federal Government departments have been required to endure efficiency dividends in return for additional dedicated funding - for specific activities financed by new policy proposals. This has led to the development of paradigms based on the curtailment of 'waste'; something I unfortunately see every time I drive past one of our Council's road gangs.

From my observations Council has not invested wisely in many areas. By way of example, a couple of years ago Council engaged a contractor to repair and re-surface specified areas of Woodbridge Road at Menangle. When completed the work was obviously sub-standard, and after the first rain (a couple of weeks later) the road was again severely potholed, to the extent that it was not only a disgrace, it was dangerous. I do not know how Council negotiates its contracts, but given the shoddiness of the work it should have been the contractor's responsibility to repair the work in a timely manner and to a standard acceptable to the travelling community.

Before actively considering any rate increase I need to know what cogent interventions Council is going to introduce in order to reduce, but more particularly avoid, waste.





We attended the meeting held in the CWA Hall on the l6th inst., and can only say that we comprehend the difficulties for our Shire Council to attend to the expected requirements of ratepayers and hope to keep within the current rate charges. We unfortunately would have to agree that an increase is necessary and if it can be within the "middle range" bracket, then we feel it may JUST be acceptable to most constituents.

However, we have submitted an application to have a small section of our property made available to be given a separate title so that we are able to sell this approx. ¼ acre area. We are in a rural residential area and the current laws do not allow for us to subdivide in any way. We are hopeful that your continuing application to the State under "Growth Management Strategy" policies may eventually lead to a possible 'change of rules in isolation 'which would not only benefit so many ratepayers, but lead to growth in our Shire (more ratepayers) without impacting greatly on developments that require new roads & existing infrastructure. By this I don't mean great services, but simply allowing small acre properties on the perimeters of our towns and villages, which are currently classed as rural residential, to make small sections of their land available for resale or to pass on to family members. At present, our grown children cannot afford to buy land in this great Wollondilly Shire and so very many of us who have lived here all our lives, are not in a position to help them until we pass on and even then, their inheritance can only be left to one offspring. I feel quite strongly that a change of this nature might just bring in the extra finances required to help our Shire keep up with necessary services with perhaps only the cost of extra "garbage collection " added to the bottom line.

#### "SPECIAL RATE VARIATION 2014"

#### 1. Introduction

Picton Municipal Council was incorporated in 1895. At that time, nine community members were elected to represent the voice of the people.

The First Council was united in their civic approach to borrow money to pave the way for future infrastructure in building roads, bridges, and a Shire Hall to reflect the affluence of a rural community.

A sister council operated at The Oaks under the name Wollondilly until the Picton Municipal Council agreed to amalgamate with Wollondilly Shire Council in 1940. There was strong argument for and against the proposal, but amalgamation proved to be the best solution for economic sustainability and growth.

The new Shire incorporated Warragamba/Bents Basin in the north, Appin in the East, Nattai/Burragorang in the West and Yanderra in the South, covering an area of 2,557 sq kilometres.

Wollondilly is made up of 17 towns and has a population of approximately 50,000 people with a revenue base heading towards \$50 million per annum. Council is the caretaker of more than half a billion dollars in assets paid for by rates revenue, government grants, bequests and developer contributions over the last hundred years.

In the recent two decades, Council has been successful in achieving frequent rate rises. In 2011, Council received a further rate variation of 6% over 3 years to reduce the infrastructure backlog of approximately \$52 million, in addition to borrowing approximately \$3 million under the State Government LIRS scheme in 2013 for bridge repairs and curb and guttering.

In 2014, Council is offering the community three rate rise options before applying to the Independent Pricing and Regulatory Tribunal (IPART) to vary the rate increase from the pegged 3% annual increase.

The first option is for no special rate variation.

The second option is for a further rate rise of 8.5% per annum over 4 years to stabilise infrastructure, which will be built into the rate base at the end of that 4-year period.

The third option is for a 10.8% rise per annum over 4 years to improve infrastructure which will also be built into the rate base at the end of the 4-year period.

#### 2. Submission

The Wollondilly Residents & Ratepayers Association Inc (WRRA) resolved at our monthly meeting on Wednesday 15 October 2014 to prepare a Submission in response to Council's newsletter seeking a Special Rate Variation.

Since incorporating in early 2012, WRRA has orchestrated a campaign for a popularly elected mayor which will now be addressed by Council by way of referendum at the next Local Government election in 2016.

Additionally, we initiated a campaign calling for amalgamation/boundary variation with neighbouring councils based on our argument that the Shire of Wollondilly is too big for Council to manage efficiently in today's financial climate. We made a Submission to the Local Government Independent Review Panel calling for the democratic right of the electorate to vote for the mayor. Our call was taken up by the LGIRP.

Further, we initiated a campaign in opposition to Council spending ratepayers' money without consultation with the community to oppose the Federal Government's proposal for a second Sydney Airport at Wilton, prior to Government studies being prepared which ultimately discarded Wilton as an appropriate site.

We acknowledge that Council is responsible for the maintenance of 840 kms of roads, 90 parks and reserves, 78 bridges, 19 halls, 13 sports fields and 33 playgrounds, in addition to a huge area requiring weeds eradication, maintaining signage, fencing Council property and purchasing works equipment to undertake maintenance.

Council is responsible for managing its budget in a way that enhances public confidence. However, in the recent past, Council has spent two years and \$2 million building yet another sportsground at Abbotsford Road Picton in the first stage of a 4-stage project estimated to cost \$8 million to complete, at the expense of addressing the declining state of infrastructure.

The Council foyer has been refurbished at a cost of \$85,000 when the work was not required. It has purchased library vans that have proved to be a drain on the budget. It spends funds on maintaining Yerranderie roads that few people use. It has spent inestimable funds on legal expenses to expel an aged resident from his Cawdor property which proved unsuccessful in the Land and Environment Court. It has wasted over \$43,000 instructing Sydney solicitors to write letters to community members threatening them with legal action for fair comment on a closed Facebook site regarding former mayor Cr Benn Banasik and the Deputy General Manager. It has spent over \$75,000 on consultancy fees to opposed the Federal Government's proposal to build a second airport at Wilton and paid over \$2,000 to purchase red T-shirts for Council staff to wear with no return to ratepayers. The former General Manager has spent unlimited funds on corporate credit card expenses and Council is wasting thousands of dollars in legal fees to block WRRA from access to details of the credit card expenses. In addition to hidden wage increases, the elected Council recently voted for an undeserved increase in their fees and expenses, costing approximately \$250,000 annually to attend eleven Council meetings a year, informal

meetings, site inspections, purchase of laptops, phones and the high cost of attending conferences for no return to ratepayers. The expenses cannot be justified.

The Wollondilly community places a high expectation on the maintenance of our roads, bridges, footpaths, and curb and guttering. Over recent times, motorists have reported the worsening deterioration of infrastructure and Council admits it is aware of the situation but has persistently maintained that there is no money in the budget for repairs and maintenance. Council's argument cannot be sustained when ratepayers pay rates in return for safe roads, footpaths, bridges and curb and guttering.

Council's brochure/newsletter (p1) states that: "Without a Special Rate Variation we won't be able to maintain our essential infrastructure and services."

Further, Council states that: "Our long term financial modelling currently estimates that Council faces an \$80 million deficit at the end of 10 years unless there is a significant change to expenditure or revenue."

We submit that Council's statements validate our argument that Wollondilly Shire Council cannot cope with the growing infrastructure backlog and should consider amalgamation or boundary variation to bring about efficiency of scale across local government boundaries.

Based on the existence of deteriorating infrastructure, and the requirement for more money to maintain future infrastructure, there is no evidence to support Council's argument that a Special Rate Variation will "enable us to continue to deliver quality services in line with the expectations of our growing community."

Faced with expected population growth in the Shire, Council must consider the benefits of amalgamation for future benefit to the community. It cannot continue to bury its head in the sand and rely on rate increases to do what it has already proved is beyond its capabilities. Council must be progressive and look to the past for a road into the future by emulating survival strategies. Council is doomed if it fails to reinvent itself.

#### 3. Conclusion

The Wollondilly Residents & Ratepayers Association is grateful to Council for providing the community with an opportunity to make submissions in response to the Special Rate Variation. However, we challenge Council's claim that it is "working hard" to ensure efficiency and reviewing ways to reduce expenditure when there is no evidence to support the statement and pouring millions into another unnecessary sporting facility at the expense of priority needs calls for explanation.

Our Association is of the firm view that increasing rates will not resolve the existing infrastructure backlog over the next four years, noting that the last increase was premised on the same argument, only to be confronted with the realisation that the backlog has deteriorated further.

Our Association strongly opposes any further rate increase and calls on Council to consider privatisation of its half-billion dollar assets, resurrecting its former property portfolio from which profits would be returned to general revenue, or boundary variation/partial amalgamation of the outreach villages with Camden, Wingecarribee, Wollongong and Campbelltown in order to remain viability over coming decades.

WRRA believes that Council must move forward with the times and do what is necessary in corporate terms without further expense on the raterpayers' pocket during the lengthening economic downturn.

## Homeowners ripped off as rates rise while councillors jet to the coast

ONE third of all NSW councils will increase their rates this financial year, but councillors have found the money to jet off to a local government junket in Coffs Harbour.

The annual Local Government NSW conference will be launched by Premier Mike Baird today, and he is expected to reiterate to councillors the urgent need to put their finances in order.

Councils have until July next year to show the state government they are changing the way they operate in order to access a funding pool of \$1 billion.

With a third of councils applying to the Independent Pricing and Regulatory Tribunal to jack up rates and a third of councils losing \$1 million a day, the government is concerned the "carrot" for change is not being properly considered by most councils.

Local Government Minister Paul Toole said the number of applications for rate rises was not a good sign.

"The local government sector is losing more than a million dollars a day," Mr Toole said. "This is not sustainable. "Expecting ratepayers to fork out an extra 10 or 20 per cent in rate increases every year is not the solution to creating a stronger local government system.

"I encourage every council across NSW to consider their long-term financial sustainability and consult with their communities on how they plan to achieve this."

Councils bringing in the biggest rate rises include Maitland — which will increase its rates by 50.75 per cent over seven years, Richmond Valley, which will increase rates by 34.3 per cent over five years, Gilgandra.

which will increase rates by 29.3 per cent over three years, and North Sydney, which will increase rates by 27.5 per cent over five years.

Blacktown council is set to increase rates 11.81 per cent over two years.

Mosman, Ashfield, Shoalhaven, Blue Mountains, Eurobodalla, Wollondilly, Gloucester and Newcastle all intend to apply to raise rates.

The annual LGSNW conference started yesterday and will run until tomorrow.

The main focus of the talks will be on how councils will respond to the government's reform plans.



ON the same day Premier Mike Baird called on the state's councils to be "bold", councillors snoozed at the local government conference in Coffs Harbour.

A total of 745 delegates crammed into the C.ex club yesterday for the LGNSW conference, where the majority of motions discussed focused on state and federal funding issues. Only 61 of 172 eligible motions were voted on during a marathon eight-hour session, which included a speech from Mr Baird calling on councils to put their "pride into the back seat" and support the government's Fit for the Future program. A further 69 motions were ruled irrelevant by the LGNSW board.

Office of Local Government acting CEO Steve Orr told councillors opposing amalgamation that new details would be provided before the end of the month.

LGNSW president and Coffs Harbour councillor Keith Rhoades said while they would fight against forced amalgamations, councils should consider their options and assess whether they had the "capacity to stand alone".

Councils have until June 30 to lodge their Fit for the Future submissions, which will be assessed by an independent panel. "There is significant support available to help council through the process," Mr Orr said.

Woollahra councillor Anthony Marano (left) said he was "very tired" and described the room as "airless and stuffy".

Liverpool Plains councillor Col Stewart travelled from Quirindi, 367km from Coffs Harbour. Mr Stewart said he worked hard for his local community and had a "habit of looking down at the floor" during meetings and speeches.

A TERRIFIED Rosie Batty decided against calling police when her violent estranged husband turned up at her son's cricket practice, contravening an order to stay away from him.

Her previous dealings with police over his breaking intervention orders to see his son made her frightened to go through another stressful incident.

It was a tragic mistake that cost the life of her 11-year-old son Luke when his father, Greg Anderson, 54, bludgeoned him to death.

Months earlier she had phoned police to apprehend Anderson, but no action was taken despite a warrant existing for his arrest.

The explosive revelation emerged at an inquest into the murder yester-

day, when Ms Batty said police officers later told her a "gap" in the police database was to blame.

"They said there was no record (of the warrant). They dismissed me like I didn't know what I was talking about," Ms Batty said.

She told the Victorian Coroners Court that on the day Luke was murdered she had decided against phoning 000 because previous dealings with police had been "traumatic and unpredictable".

"I'd had some really unpleasant situations involving the police at the oval," she said.

"I didn't trust the situation. I looked at Luke and thought 'This is going to be the third time I've tried to have this man arrested in front of Luke and his friends at that bloody oval'."

Anderson had been playing with

Tyabb south of Melbourne in February when he suddenly attacked his son, killing him before police arrived and shot Anderson dead.

The court heard Luke would not have felt any pain after the initial blow inflicted by his father.

Witnesses tried to approach Anderson, 54, to help Luke but he ran at them scaring them away, saying: "He's in heaven now".

Ms Batty said a week before the murder she had given police Anderson's address after they asked her for help locating him. He was wanted on outstanding warrants and presumed he had been arrested.

Ms Batty had also phoned her local police in April 2013 to report Anderson after he had turned up at football training to watch Luke.

An intervention order was in place Luke at the cricket oval in the town of protecting Luke from his dad after he inquest.

threatened him with a knife telling him "this could be the one to end it all". Anderson had failed to appear at court for the hearing that saw him banned from all contact with his son. When Ms Batty saw him at football training she phoned police but nothing was done.

She said police told her there was a "gap" in the system and they hadn't seen the warrant for Anderson's arrest.

The tragic revelation is expected to heighten pressure on the government to address fatal system failures that may have contributed to Luke's death.

Bail documents showed that on one she occasion a police prosecutor didn't oppose Anderson's bail application in court despite the investigating officer stating he opposed bail. It meant Anderson was free to walk out of court.

To keep up with the infrastructure backlog, Wollondilly residents are being asked to support another special rates variation.

With only weeks into the top job as the shire's general manager, Luke Johnson isn't slowing down to smell the roses, but rather has clear sight of the backlog of works piling up. Mr Johnson is asking for a rate special variation - similar to what his predecessor has done before; he believes it's only way in sustaining what the local government area has.

"There's approximately \$15.8 million worth of infrastructure backlog; how we go about addressing the issue is to have a conversation with the community, which is so important," Mr Johnson said.

There are three options being proposed the first is the do nothing scenario where the annual automatic three per cent rate peg is passed and existing infrastructure such as roads, parks, sportsgrounds, bridges and halls will be left to continue to deteriorate.

Option 2 looks at "stabilising" what is already with 8.5 per cent annual increase over four years (including the rate peg) - this will provide some additional funds as well as new infrastructure.

Option 3 is about "improving" what's in the shire and would include a 10.8 per cent annual increase over four years (plus the rate peg) - this will allow more available funds for new infrastructure.


Mr Johnson said while the council trims and continues to look for "efficiencies and improvements" it's not enough to generate the \$80 million needed in the next 10 years. If a special rates variation is passed, it will be the third in a decade.

Mr Johnson is aware that there might be some opposition and acknowledged that some people might be doing it tough, but it is envisaged the average increase will be \$40 a year. He said it will leave the shire in good condition for future generations.

The area has 800 kilometres of roads, 17 towns and villages each with their own hall and sportsgrounds as well as numerous bridges - these features are unique to the shire. "What legacy are we providing for Wollondilly? What's going to be here for our children?

"Let's fix the problems to ensure longterm viability and leave the place in good shape."

It's a sentiment that's shared by the new, but familiar mayor, Cr Col Mitchell who said there have been some improvements since the special rates variation first started. "This is something for us to become more sustainable; bring our roads up to standard was one way the special rates variation has worked previously. This variation is for the bridges, cul-

verts and roads; not for new infrastructure."

Cr Mitchell said a lot of road work has been done to cope with the increased traffic and heavier vehicles being produced. He said the roads were initially built for a different era. Mr Johnson added that with the population expected to increase, more work needs to be done.

If any special rate variation is adopted after four years the increase will be included in the annual rate base.


The council will be holding information sessions, community meetings, and drop-in question and answer sessions until October 31. There's a dedicated website with information on each of the options being considered; the effect these will have on rate payers and the impacts each option will have on community infrastructure and services into the future.

Do nothing isn't an option at all - it's only prolonging the inevitable and passing it along. There's a lot of growth planned for the shire and this will also mean more rates and even contributions from developers to build new infrastructure, which as the years pass will become well-used and in need of repair - thus beginning the cycle once again.

The rate variation is one of these matters that will no doubt generate much discussion and some finger pointing about wasting money and keeping a tighter rein on the budget - but at the end of the day the right decision has to be made in respect to the area and future generations.

Rail travel on the way With a new rail line closer to opening in the south west, more transport options should become available. The Edmondson Park and Leppington railway stations are well on the way to being operational in early 2015 and this could mean reduced traffic on the main roads out of Camden and Wollondilly. Let's wait and see what the take-up rate will be and if people are prepared to give up their cars for trains.

With so many more people moving into the area, it is a smart move to open

In a world first, Kids Helpline recently launched a project to provide safe and secure online group counselling to Australian teenagers using social media.

The pilot project, led by University of Sydney Psychologist Dr Andrew Campbell, responds to the gap in services and growing demand to migrate e-mental health support online.

"One in three teenagers has a social media account and one in five will suffer a mental health problem," Dr Campbell said.

Social media counselling is the new frontier for mental health because it responds to the changing habits of at-risk teens who are digital natives and increasingly using social media to connect.

"Social networks are a preferred option for young people seeking support. In fact research reveals Australian teens are more likely to talk to others via social networks about their problems than they are to get help face-to-face from a trusted

person like a parent of counsellor.

Dr Campbell said while the internet posed inherent dangers, safe and secure social media counselling was the way forward to help teenagers with anxiety or depression.

Kids Helpline CEO Tracy Adams said the past five years had seen a huge growth in young people seeking help via online counselling, with it now accounting for 42 per cent of all Kids Helpline counselling sessions.

"This pilot project addresses a growing need for online support," Ms Adams said.

The project will trial the use of the Google+ social networking platform to help young people manage their depression and anxiety. Under project, young people who contact Kids Helpline will be assessed and, if appropriate, directed to secure social networking areas for their age group. Each group will have a maximum of 10 members who are all dealing with similar issues and so can share their experiences and gain support from one another.

### Declaring war on ISIL

No prime minister will ever take lightly the decision to send Australian troops into any military conflict. As prime minister, Sir Robert Menzies in 1939 had to make the announcement that Australia had joined the war in Europe, Prime Minister Tony Abbott has relied upon internal reports the need to commit 600 troops to Iraq to gather intelligence, help facilitate air and ground missions, assist with humanitarian aid and stop the progress of the Islamic terrorist organisation ISIL.

It is concerning that there are people living is Australia that are happy to support a terrorist organisation like ISIL, and with the recent beheadings of a journalist and aid worker by ISIL these people here don't seem to have a problem with such primitive behaviour. Australia's terror alert was lifted to high because of evidence of potential terrorism threats within our borders of which the Abbott Government proactively requested that phone records be kept by telephone providers for two years, which has led to information that warranted dawn raids on terrorist suspects conducted in Queensland and Sydney this week. Passports have been cancelled for those Australian citizens who've elected to participate in fighting overseas with ISIL, and to prove that the connections to ISIL are very local; a Sydney money transfer business has been suspended from trading, because of millions of dollars of financial discrepancies believed to have been funnelled to ISIL.

Different to the previous war in Iraq, Australia has been

The Islamic State of Iraq and the Levant (ISIL) is so extreme that it would be difficult to define it as an Islamic group in the same way it would be difficult to define the Ku Klux Klan as a Christian movement. The group's genocide practices against the Kurds and its claim to be the leaders of the Islamic faith around the world are so absurd that not even Al-Qaeda could continue to support it. ISIL would be best described as a rogue terrorist organisation with a relatively small support base in the Middle East. It does not have the support of a nation and it does not have a legitimate claim in the eyes of the wider Islamic community, Sunni or Shiite. Its desire to control an Islamic state which includes Palestine, Israel, Jordon, Lebanon, Syria, Iraq, Iran and areas of Turkey is absurd in the eyes of all Middle East nations.

Equally ridiculous is that in 2003 former Liberal Prime Minister, John Howard, supported the then President George W Bush and with the Brits and Americans formed a Coalition of the Willing and went to war in Iraq to overthrow Saddam Hussein. That war fostered terrorism in Iraq and nurtured the conception of ISIL. During Saddam's years in power, terrorist groups such as Al-Qaeda were unable to get a toehold in Iraq. In what must be regarded as the biggest, dumbest political blunder ever made by an Australian prime minister, the decision to send troops into Iraq was morally bankrupt and will be judged accordingly in history. This decision was far worse than the Harold Holt decision to send troops into Vietnam in the late 1960s and it is the reason why British, American and Australian citizens are now being targeted by ISIL today.

We are facing a new and very dangerous terrorist group with

St. Francis of Assisi (1181-1226) was a remarkable individual.

Chesterton, described Francis as "the Saint of Holy Topsyturvydom" who "chose weakness instead of strength, vulnerability instead of righteousness, truth instead of practicality, honesty instead of influence".

Defying the social mores of his day, Francis succeeded in living a life of earnest compassion; the needs of others were his highest priority.

Significantly, a recent author (Christine Mallhouri, 'Waging Peace on Islam', Monarch Books) describes Francis's opposition to the savagery of the Crusades, and his challenges to

As a rate payer at is with some regret that I must submit my comments concerning the application for a Special Rate Variation, as this approach seems to be used as a general panacea to remedy deficiencies in funding.

The whole idea of rate pegging a I understood it was an attempt by the State Government to prevent Local Councils, going on frolics of their own and becoming involved in various activities, ie campaigns against airports, overseas trade embargoes, green bans etc, which indeed council should not be involved in, many of these under the heading of community involvement. Some of these interests led to huge legal costs borne by ratepayers for no return.

On the 14/2/2011, I submitted my comments, recommending against a special rate variation, for various reasons. At that time council submitted 4 scenarios for consideration of which you are no doubt aware. A 6% increase was given over a 3 year period which according to Council fell short, however access was given to the State Governments Local Infra Structure Scheme which ameliorated matters and allowed much needed works. Also a .4% carbon tax rebate was received. It is noted council carried on .

For those of us on fixed pensions , we receive CPI ,INCREASES, THE SAME APPLIES FOR AGED PENSIONERS . I know of no employed person who receives an increase of 8.55 OR 10.8% rise per annum. I nfact teachers receive something along the lines of 2.8% and NSW Public servants have their salary pegged . I can understand that there is a large back log of Infrastructure works but this has not happened over night .

I have lived in the Wollondilly Shire since 1979, and have enjoyed the rural atmosphere. When we arrived council was involved in basic activities, such as road works, Town planning, parks gardens, library swimming pools septic removal and other council activities. Other community activities were completed by members of the community with minimal council assistance.

Let us look at Councils Botanic Gardens estate, a council initiative, and to my mind a resounding success. Then followed the Jarvisfield Estate starting off at 1 acre blocks and down to smaller blocks, the engineering and road works met the required standard. The new estate followed, but the requirement to develop these smaller blocks, must have cost thousands. I can understand council wanting to fireproof their future maintenance needs, but I believe that the road construction would equate to an interstate highway. Indeed over engineered, young people will pay a lot for this aspect.

Time moves on and the new Local Government came into being .This act does give councils wider powers , but at what cost to the rate payers . I have taken the opportunity to peruse , various publications , councils web site , and of course Addressing Our / your future needs, the previous General Manager Residents update June 2011. Of particular note is the document on the internet which indicates what council provides . Let us now consider this aspect .

1 Child Support Services . Why is council involved n Child Care , surely this is a State Government responsibility, and administered by the Dept of Family and Community Services, NSW Dept of Education and Communities . Unfortunately this has been contracted to the ratepayer to meet the short fall . Unfortunately the State Govt provides the seeding finance ie dollar for dollar , then retreats and council is left with the on cost and maintenance . As time goes by then this becomes a community expectation , and council accepts responsibility, which really is not council responsibility .

In the true spirit of community involvement, child care services and other interested bodies, can organize themselves, under the Incorporation of Association legislation and in true community spirit look after themselves, with a small amount of help ie some Tennis Clubs.

2 Community Development this is a growth Industry ,, but the community must play a role , and not require council staff to help and monitor their activities and provide funds .Why is the council managing a community bus , albeit with volunteers ,, is not this a matter for the Dept of Transport or Rta

3Youth Development: Again I feel this is the responsibility lies with a State Government Department, duplication must be guarded against or scarce resources leak into other areas.

4 Community Safety :Surely this is in the province of Police ,Deptof Transport , Rta Maritime and Health

Emergency services is clearly under the auspices of the SES. This again is a large organization with salaried officers, and should look after their own affairs especially buildings. Why is Wollondilly Shire Council funding upgrades to the SES WHEN THIS IS A STATE BODY. The volunteers do a great job, let the ses look after itself as they come under state control.

Turning to the Rural fire Service , this is now a large bureaucracy in itself , with salaried officers , with a huge headquarters at homebush it is aeons away from the old fashioned volunteer bush fire brigade .Why are ratepayers maintaining the rfs fleet and buildings . The Thirlmere fire station opened with a new \$400:000, fire station with \$50:000, being contributed by council . Every day we see the 4 wheel drives come over the mountain roost at HQ IN Picton and go home again, not to mention the Helicopter, why are we contributing ? The local volunteers to a great job , but are subject to direction from Hq homebush, let them look after themselves .

5Cultural Affairs; Indeed there are State departments that look after these affairs, and of course they offer funds, which are clearly not enough. Art exhibitions and events who picks up the shortfall? Who pays

6 Economic Development: I strongly support local business, and industry, however Maldon Concrete Works 40 to go, Tahmoor Pit more to go. I believe that State and Federal Bodies are responsible for this aspect.

7Environmental Health and Regulatory compliance :Again some State responsibilities have crept in here ie food regulation, the majority are council issues, but again Councils must not accept State responsibilities without adequate funding.

In summary in my time in the Wollondilly Shire, there has been a marked growth in community expectation,, whether it has been aided and abetted, by some counsellors, which are not councils responsibilities,, but which unfortunately as the shine wore off, are now subsidised by rate payers, nothwithstanding they are State Government responsibilities.

Since I have been here and in councils defence, road and infrastructure projects have occurred, but unfortunately good intentions have been eroded by leakage of funds for community expectations, and short term solutions. The Razor back road for at 4 years barricades have been put in place awaiting funds for road maintenance, surely the cost of said barricades must be astronomical. Also the temporary pedestrian bridge in Menangle street following flood, how long will this remain or will we await another special rate variation.


But let us pause here ,Councils organization chart of 2010 showed a General Manager , plus 2 Assistant General Managers . It is indeed pleasing to note this structure has been maintained , however the Assistant Managers, are now Deputy General Managers , I trust with increase in remuneration . Comparing the organization chart of 2010and the new schedule of responsibility of Deputy General Manager s ,, perhaps Infrastructure ad work and Environment , and community services seem to be re allocated .

In my humble opinion, Infrastructure works could go under economy, the rest could go back to the manager community services, flatten out the managerial services, let the managers manage, and thiswould lead to the Deputy Managers position dealing with community involvement being abolished, taking into consideration the matters I have raised above. After all only large State Government Departments responsible for State wide matters have a structure with 2 Deputy Gms. Whilst on the subject of staffing there seems to be a continual stream of new positions being advertised in the Bush Telegraph? Have staff numbers increased.

Concerning the back log most large entities make provision for unforeseen works , maintenance allocations , the back log must have come to notice some time ago .

In view of the matters raised, I believe that there should be no increase in rates, the whole matter of community involvement must be looked at to ensure, we are getting value for money. The relationship with other State and federal bodies, government reviewed and if proper funding not obtained overlaps must be curtailed, and council withdraw from these areas. The role of Deputy General Manager involved with community involvement be abolished, and other aspects of that position be devolved and let the mangers manage.

I hope you take my submission into consideration.









- (6) Encourage all levels of Government to assist genuine farmers (particularly those caught up in similar circumstances)

- (7) Offer more support to your existing Wollondilly rural liaison committee.

In our opinion Road Safety is the Maintaining and upgrading the current Roads; This does not mean reducing speed limits but Yes Educating is needed, after all Our Roads are Rural. Therefore any traffic Infringement revenue acquired by the State Government from within our Shire from our Residence should be feed back for Our Shires Road Safety Program which will be used for maintaining, repairing and upgrading Our Roads.

All this said additional funding should also be granted from the State Government to upgrade and maintain The Main Roads within our Shire, Roads such as Old Hume Highway (Route 12 between Camden, Picton, Tahmoor, Bargo and Yanderra), Silverdale Road, Picton Road, Barkers Lodge Road, Burragorag Road, etc.

General Manager Wollondilly Shire Council Dear Sir

We have lived in the Wollondilly Shire for 32 years. We are totally opposed to any more special rate variations. We notice in all the documentation and publicity about this latest rate variation that nowhere does the Council state how much rates have gone up in the past 8 years or so, and how many rate variations have been applied for, and approved against the wishes of the vast majority of Wollondilly residents, in recent years. So Wollondilly rates have gone up by a huge amount, when you calculate the accumulative effect of all of these rises. When will the Council ever stop seeking more extra rate increases?

We notice in the chart provided about Wollondilly and other Councils with regards to income and expenditure, that Penrith and Hawkesbury are on a par with Wollondilly with regards to Income per capita, and that Campbelltown actually receives quite a bit less per capita for their huge infrastructure. And it was not that long ago that Wollondilly rates were quite a bit lower than the rates of those Councils. Also Campbelltown, Penrith and Hawkesbury Councils spend much the same per head as Wollondilly. As far as the road length goes, the other Councils have much more infrastructure to maintain because they have large urban areas to be serviced, so that it not an argument to be used.

Council can seek savings in other areas or reduce some services instead of raising rates. Council can also sell some old buildings which are not needed today and which require a lot of maintenance, such as old halls. The can reduce the number of committees as well. The Council could sell the old Post Office building and put tourism information in the Council building 100 metres up the road, or in the Rail Museum at Thirlmere, for instance. When will Council cease seeking special rate increases if they do not seek to make the hard decisions and reduce costs.

So we strongly oppose this rate variation idea because:

- 1. There has already been a huge increase in rates in Wollondilly in recent years.
- 2. Council should be seeking cost savings, even it means cutting some services, or else the Council will continue to apply for these special rate variations every few years as they are doing now. And they are accumulative. Residents here already have extre costs of living because large numbers of them need to commute to work outside of the Shire, there being very few work opportunities in Wollondilly. These continual extra rate increases, which keep on accumulating onto previous increases, impose a huge financial burden on the Shire's residents.

I realise these comments come after the proposed cut off date of 31 October, However, they need to be made and acted upon in any deliberations regarding increased rates.

As a long term owner, resident, developer and community participant I do not see the validity in the idea to increase rates to sustain a business, at least not without making structural changes to the income and expenditure base of the LGA.

It has been apparent to me for at least three decades Wollondilly's boundaries must change to reflect the commerce, social interaction and use of facilities

Wollondilly exists only as an historical name. It does not exist in the consciousness of the ratepayers. It is not a market

Two telling lines in the brochure are the "roads Bridges and Footpath expenses per capita and "metre road length per capita". Wollondilly is king of both parameters compared to the five LGA's quoted. This is a bad statistic to own along with the Lowest revenue of the Five LGA's

Put up the rates then you say?

As a commercial landholder in Picton I can say we pay council \$26,000 pa for 15000m2 over two titles. For that we receive little or nothing. The retail environment is changing in Picton as elsewhere due to changing technology, work patterns, transport connections but most notably improved facilities in adjoining LGA with higher populations, less roads to maintain and better shopping areas . Our rates go into general revenue to subsidize rural roads to convey residents to our opposition in better shopping centres in neighbouring LGA's

Putting up commercial rates will further curtail commercial development here, not enhance it. We will get further behind in service delivery.

A far better scenario would be to give neighbouring LGA's some of our low density, large road budget areas. Campbelltown, with 5m of road per capita could take Appin, which has no social or commercial relationship with the rest of Wollondilly.

Similarly, Penrith, with 6m of road per capita could take Warragamba/Silverdale and south to Orangeville. These areas have no connection with the bulk of Wollondilly's population, where the rates are primarily raised, both commercial and residential. They use the services of Campbelltown and Penrith respectively. Wollondilly's more efficient rates collection to length of roads precinct is from Razorback to Bargo area.

It is most questionable whether multiple administration centres are required with such short distances between Wollondilly, Camden and Campbelltown in the days of internet technology. Certainly the commerce of the region is integrated, why not civic service delivery? All

administration sucks up money from its designed end use. A more favourable outcome may be to amalgamate with Camden and Wingecaribee to the south , making Picton the Capital of the combined LGA ( of course). This makes sense from a regional employment perspective. It gives Picton a reason for being , is the most scenic town in the combined district and central to all three LGA populations.

Further, rates need to be sourced from the new commerce. Under the LEP any residence can be a commercial premise employing three people without DA, and without charges !! Technology is driving shopping and work from home. The traditional rate collection areas are paying for this, whilst trying to compete with the internet. This is just not sustainable as commercial property values fall.

I suggest a rate on all internet connections. That way activity is taxed at source and all users of facilities pay for facilities. It is extremely efficient to ax this way.

Another way of attaining revenue needs to be investigated. I don't see any utility in maintaining a rates system in the 21st century. Rates are tied to land as that was a parameter available in 1919 when the Local government act was enacted. There are better proxies for service delivery and its associated income attainment than rates. I suggest car registrations or utility connections, as they are digitised, transferrable and reflect the biggest costs of facilities, people. Private contractors could use LPI's land title system for rubbish collection. Council could use it for house numbering, or let LPI manage their own numbers.

Putting up rates without structural change is a con. More population in denser centres and less roads per capita measures should be implemented immediately. Council will have more income with less roads to spend it on, allowing a better social dividend.

## Fit for the Future

### You state:

We are having this conversation with the community because we want to ensure we are "fit for the future" and the special rate variation is an important step towards achieving this.

I support Option 1 only, I do not support Options 2 or 3, as I am already unable to meet the inflationary abnormal demands from council for permanent Special Rate Variation increases that I cannot afford as an old age pensioner.

Unfortunately, I was away when you held your meetings at Warragamba, Appin and Tahmoor.

I have telephoned council and spoken to Andrew, who has stated that where my overall costs for permanently increased rates for 2014/2015 rates have only increased in dollars by only 2.5% then they are OK,

Could you please have my rates checked, as the Ad valorem amount has increased by over 9%

and this is not OK by me.

I would not have expected your last SRV determination to have been permanent, as it has been made without a return to the permanent base pegged rate variation value, as it should have been able to be expected by me and by this community, rather than permanently increasing councils revenue in perpetuity, by 19.1016% as opposed to falling back to the permanent pegged rate value base, yet cleary your success with IPART for only 3 years at 6% per annum, in the light of the majority 53% of this community having clearly stated that they were not in favour of council seeking a 6.7% increase for 7 years, as highlighted in the IPART determination for Wollondilly Shire Council and subsequently reduced by it, thus observing the wishes of the majority of the community.

Would council be able to rezone and subdivide its 12 Ha property into an Industrial Estate, to provide jobs in this local government area? That would be really good I think.

When will the XPT do what it does in outlying areas such as Picton across the state, ie., pick up and set down passengers other than first stop Campbelltown then Mittagong. Or is Picton the seat of local government, just a sleepy hollow not worth a mention.

We will soon need a Public Transport System, for our Doctors services at The Oaks and ALDI at Tahmoor.

We live in Wollondilly council area but by car we are served best by Camden Narellan, Mt Annan and Campbelltown Services provided by other Local Government. You have to go to these areas as we have no specialists or hospitals in your area.

I note the previous General Manager, J.L. McMahon (now resigned 2014), found that a decision to reapply for a SRV, in 2014/2015 was a daunting task, as he stated, "This is a monumental decision, for me, and council, they, did not feel easy about taking" and did not apply to IPART, now we are again being bothered to consider not two but three options provided in 2014/2015 for yet another SRV. This is very worrying as I totally disagree with inflationary permanent SRV's and we don't want to have to sell our home.


I seriously question, the validity of a council that applies each of its SRV determinations as permanent, with a cumulative affect.

It cannot be forgotten and council is reminded, the IPART made it very clear to council it was not to use funds achieved by its determination for purposes other than those specific purposes as applied for and achieved by a council. My concern is if the cumulative effect of these permanent SRV's is permanent then your council is doing what it likes with addition monies received in perpetuity, after the expiration of the prescribed period of the determination.

An IPART SRV determination should not under any circumstances, in my view be a licence for councils to print money after the prescribed period.

Attention is required as below:
