1. <u>Proposed modification of existing parking zone on Camden Road, Douglas Park</u>
(west side) outside Fidgety Frogs Child Care Centre and line mark 4 kerbside parking spaces.

### **EXECUTIVE SUMMARY**

Request to modify existing 2P time restricted parking zone to ¼ P time restricted parking zone and line mark 4 x kerb side parking spaces along Camden Road, Douglas Park outside Fidgety Frogs Child Care Centre.

### **REPORT**

Council has recently received a request to review the existing traffic zones adjacent to the new pedestrian refuge islands near the junction of Railway Parade and Camden Rd, Douglas Park to provide adequate parking spaces and service the adjacent Fidgety Frogs Child Care Centre. An option identified is to modify the existing 2P time restricted parking zone to ½ P time restricted parking zone and line mark 4 x kerb side parking spaces along Camden Road, Douglas Park outside Fidgety Frogs Child Care Centre. This will encourage high turn around parking spaces for the Centre and ensure maximum parking arrangement with the marked spaces. The implementation of this proposal would improve parking availability at the location.

### **CONSULTATION**

On site meeting among Councillor; Council Staff and Child Care Centre Management was carried out to discuss and explore improvement options available. The proposal will undergo public consultation prior to implementation.



### 2 <u>"Bold Jack Country Music Festival", Warragamba – Request for Road</u> Closures

### **EXECUTIVE SUMMARY**

The Organising Committee for the Bold Jack Country Music Festival has submit a revised request to Council for permission to close a number of roads to permit the "Bold Jack Country Music Festival" to proceed and allow traffic to be detoured during these closures.

The previous request was not supported due to an excessive number of roads close and have significant traffic impact on the surrounding area.

The Bold Jack Country Music Festival is to be held over on Saturday 9<sup>th</sup> December 2017. This year is the first time such festival event is held in Warragamba.

### **REPORT**

The organiser of the Bold Jack Country Music Festival has again submitted a revised request to Council to give permission to close limited number of roads and allow traffic to be detoured during these closures. The venues involved are Warragamba Memorial Park; Warragamba Civic Park and Warragamba Town Hall where the music performance is held. As a precautionary measures and to ensure the event is conducted in a safe manner and minimum disruption to the wider community, limited number of road closures are required.

Council has imposed a condition for the hire of the venues to prohibit alcohol consumption outside the venues especially on public road reserve as the precinct is within the Alcohol Free Zone Area.

The road closures are proposed to be in place between 11.30am and 11.00pm on Saturday 9th December 2017 involving the circuit roads adjacent to these three venues.

It is recommended that Council approve the road closures subject to the requirements for the issue of a permit for Road Event – Road Closure.

### **CONSULTATION**

Council staff has consulted with the Police and Bus Operators regarding the circuit roads closure and they raised no objection to the closures.

All residents will be notified of the event through letterbox drops and local newspaper notification two weeks prior to the event. Notices will also be posted in local noticeboards, shops and local Facebook pages.

Advance notice will be displayed a week prior to event at the selected locations advising of changed traffic conditions and event.

### **TMP Details:**

Event Date: Saturday 9<sup>th</sup> December 2017

Event Time: 1200 – 2400hrs

Road Closures: Civic Circuit from Weir Road to Fourteenth Street only

### Road Closures detouring traffic via alternate roads

1. Road closed sign on Fourth Street between Weir Road and Fourteenth street

2. Changed traffic conditions ahead sign at Weir Road, Fourth Street and Fourteenth Street.

Note: Please see Traffic Control Map.

### Objectives:

- 1.1 To ensure that the Bold Jack Country Music Festival celebrations are conducted in a safe manner with minimum disruption to the wider community and businesses.
- 1.2 To provide alternate routes for residents and visitors alike.
- 1.3 To provide high level description of the closures and various traffic, transport and pedestrian management

### Residential:

2.1 All residents will be notified of the event through letterbox drops and local newspaper notification two weeks prior to the event. Notices will also be posted in local noticeboards, shops and FaceBook pages.

### **Event Parking:**

- 3.1 Parking spaces will be available on Fourteenth Street and Weir Road;
- 3.2 Many people are able to walk to the event to reduce the amount of car spaces required;
- 3.3 Recommendation of Public Transport;
- 3.4 Parking in Church grounds (Anglican, Catholic and Baptist), outside swimming pool and in the recreation park.



### Road Closures and Detours:

- 4.1 Changed traffic conditions ahead sign on Weir Road, Fourth Street and Fourteenth Street
- 4.2 Road closed sign on Civic Circuit at Weir Road and Fourteenth Street as per Traffic Control Map

### Traffic Control:

- 5.1 Accredited RMS/RFS traffic controllers will install barricades and signage and maintain road closure and traffic points as per the Traffic Control Plans.
- 5.2 Traffic control plan drawn by Eric Murphy Card No. 0038851091
- 5.3 Traffic Controller John Webb Card No. 0023088104
- 5.4 John Webb is in the Silverdale Rural Fire Services and other members of the SRFB are also accredited to do road closures.

### The Event:

- 2.1 Event operations The festival will be held in the Memorial Park and the main concert will be held in the evening inside the Warragamba Town Hall.
- 2.2 The Event road closures commence at 1130hrs
- 2.3 Civic Circuit to remain closed until 2300hrs when closure will be lifted and traffic will return to normal conditions

### Access:

7.1 Emergency vehicles will have access and exit at all times.

### Wollondilly Shire Council:
