3. **Rescind resolution No.240/2020 of 17 November 2020 (Road Widening and Acquisition of Land No.213 Menangle Street, Picton) under s372 of the Local Government Act 1993 on the basis of the Picton Town Centre Road Improvements Future Modelling Report (Stantec, 2023).**
4. **Write to the NSW Premier, Minister for Roads, Member for Wollondilly and Commonwealth Member for Hume reconfirming Council's position for the Picton Bypass.**
5. **Note the issues projected to be experienced at the intersection of Barkers Lodge Rd and Argyle St in medium-term.**
