There are four permanent members of the Traffic Committee, each of whom has a single vote only. The members are representatives of the NSW Police Force, the RMS, the Local State Member of Parliament (for the location of the issue to be voted upon) and a representative of Council.

1.1 WONGA ROAD, PICTON - PROPOSED TEMPORARY P10 MINUTES - AT OTHER TIMES - SCHOOL DAYS ONLY (R5-1) PARKING ZONE

RECOMMENDATION

That Council implement a temporary "P10mins - All Other Times – school days only (R5-1)" parking zone within the time restricted Bus Zone on northern side of Wonga Rd opposite the Picton Buslines Depot entrance as shown in the attachment of this report.

COMMENTS

Chris Moule (Picton Buslines) noted that buses would only require use of the Bus Zones on Wonga Road from 8am to 9am and 3pm to 4pm.

The Traffic Engineer confirmed that although that may be the case, Council wish to keep the implementation of the Bus Zones between the hours of 8am to 9:30am and 2:30pm to 4pm, as per standard school bus zone arrangements.
