Defibrillator Update

A metal box needs to be purchased for the old defibrillator to be housed in for installation outside the chemist in Douglas Park.

The new defibrillators are wired to an electricity supply – Christine to obtain a quote from the electrician to have this work done.

Hall Upgrade

Christine and Max met with Air Conditioning company Shear Comfort and 3 quotes have been obtained for different options. Decision was made to opt for the 2 x split systems in the main hall area. All were in favour. Melissa to apply for a Grant to South 32 for Air Conditioning and flooring together.

Oval

The current condition of the oval is very poor. Complaints have been made by referees to Douglas Park/Wilton Football Club and patrons of the Agility Dog Association of Australia regarding the poor condition of the oval. Christine to email council again regarding the upgrade of the oval and to ask the times the sprinklers are on.

Solar Panels

Advice to be obtained from the engineer of Merrick to obtain advice regarding panels being installed on the Cola.

Douglas Park/Wilton Football Club

Soccer have requested permission to access to the old storage area, so that they can use this as a thoroughfare when they are having their barbeques under the breezeway. All in favour.
