Pricing and Payment

The Bargo Waste Management Centre (Bargo WMC) weighbridge is a certified measuring device. All customers entering the site agree to the weights displayed on the weighbridge and to pay in full the total amount payable upon exit at the weighbridge office. Load classification is determined by weighbridge staff.

Centre charges are applicable to waste generated as a result of:

- People living in a residential property which includes the general clean-up of household items or general household maintenance. This does not include materials generated as a result of large scale renovations or demolition.
- A person or business entity buying, selling or exchanging goods or services at a residential or commercial property located within the Wollondilly Shire Local Government Area.
- Examples include but are not limited to renovations, replacing materials or items or gardening/lawn mowing service.
- The operation of a commercial, industrial, rural or residential property operating an authorised business within the Wollondilly Shire Local Government Area.

Please note minimum entry fee applicable for all weighted items

- Failure to pay the fee generated by the weighbridge will result in the following three actions; debt recovery action, prevention of re-entry to the site and/ or NSW Police action.
- All debts must be fully paid before re-entry and access to site services is provided.
- All vehicles are weighed in and out to calculate the net weight disposed. Weight is rounded to the nearest 20kg.
- Most prices are based on weight however certain items are charged by quantity as detailed in the price list.
- Bargo WMC only accepts EFTPOS and credit card (Mastercard and Visa) payments. 1% merchant fee applies. Cash and cheques are not accepted under any circumstances.
- It is the responsibility of the customer to declare all waste and recyclable materials upon arrival at the weighbridge.
- Sorted recyclable and mixed waste loads will require multiple trips across the weighbridge to access reduced fees.
- The appropriate charges will be applied on exit to all customers identified by facility staff to have disposed of undisclosed waste items.
- Loads contaminated by materials not disclosed upon entry to the site may incur a re-load fee.
- A minimum charge applies to all chargeable waste loads.
- The Goods and Services Tax (GST) are included in waste charges.
- Facility staff may visually inspect loads via video camera surveillance and have the authority to take photos of disputed loads.
- During power outages the weighbridge is non-operational and the site will be closed to the public.

Customer Site Entry and Use

Only waste generated in the following Wollondilly Local Government Area (LGA) suburbs is accepted:

Proof of Wollondilly LGA residency is required to be shown on entry to the facility by all customers.

Acceptable forms of evidence include NSW Drivers Licence, Service NSW Photo Card, Current Rates Notice or Current Utility Notice from Sydney Water or Electricity Provider. Failure to supply proof of residency will result in refusal of entry.

Commercial operators are required to produce proof that the waste load entering the facility has been generated from a property located in the Wollondilly LGA. Property owners will need to provide commercial service providers with acceptable forms of evidence which include copies of NSW Drivers Licence, Service NSW Photo Card, Current Rates Notice or Current Utility Notice from Sydney Water or Electricity Provider which identifies the Wollondilly LGA property which is responsible for the waste. Failure to supply proof the waste load has been generated from a property in the Wollondilly LGA will result in refusal of entry.

- Abide by covid safe site procedures in operation. Failure to comply with all health safety procedures will result in refused entry to the site
- Cover your load.
- Enclosed footwear must be worn prior to entering facility.
- No smoking.
- Children under 12 years of age and pets must be supervised and remain in vehicles.
- Drivers must adhere to the 10 km per hour speed limit and facility signs.
- Seatbelts must be worn.
- Hands free use of mobile phone only.
- Pedestrian access to the facility is not permitted.
- All vehicle entry and exit is via the weighbridge following the traffic light signals.
- All vehicle occupants must remain in the vehicle while on the weighbridge.
- Follow directions from facility staff.
- Vehicle engines must be turned off when unloading materials.
- All materials must be unloaded by the customer into the correct locations.
- Check all doors, hatches and gates are closed after unloading.
- Offensive language and unsafe behaviour will not be tolerated and offenders will be excluded from site and/or NSW Police assistance.
- Customers who are found to have deposited non authorised items will be excluded from the site.
- No photographs to be taken on site without prior authorisation.
- No scavenging.
- 24 hour camera surveillance operates on site.
- The facility can be closed at any time in response to poor weather conditions and site safety.
- Staff can refuse to accept items or materials which the facility is not licensed to accept by the NSW EPA. This includes asbestos, food waste, medical waste, liquids, chemicals and paint.
- On site plant and machinery must not be approached.
- Report any incidents to facility staff immediately.
