I would like the following noted for tonight's Mayoral Minute.

That given the recent changes to the Greater Sydney Commission District Boundaries, Wollondilly Shire Council seek to have a MACROC working group formed to consider opportunities and challenges associated with potentially revising MACROC's structure and membership.

Following its adoption at 20 November 2017 Council meeting, the 2017/18 First Quarterly Review document has been under final review prior to publishing.

As part of this review, it was recognised that some of the information regarding the capital works program for the remainder of the year could be clearer with respect to the estimated costs of some of the projects, especially those that span over more than one financial year.

Accordingly, some revised pages were provided to Councillors under separate cover. These replacement pages require a Council resolution to replace those contained within the document that was previously considered on 20 November 2017 with the whole document to be approved for publishing, noting that the changes do not impact on the budget variations or progress report detailed in the original document.
