Matters can be submitted to Council up until 12 noon on the day of the Forum.

The person must be in attendance at the Special Community Forum and identify themselves on the question form. Each participant will be allowed to submit a maximum of two written questions.

A range of questions will be selected from those submitted on the night to be addressed. The selection will be based on topic range to avoid duplication and equal representation from participants.

The Chairperson will invite the person to speak. Each speaker's time will be determined by Council's Community Forum Guidelines, with each speaker allowed a maximum of 5 minutes.

Up to an hour will be allowed for Community Question/Statement time.

All questions will be provided with a direct answer where possible. Where an answer cannot be given on the night these will be followed up and dealt with at a later date.

The style of the Special Community Forum will be in accordance with the rules of conduct contained within the Community Forum Guidelines
