Noted that stealing from motor cars is generally due to cars being left unlocked. Usually looking for credit cards.

Picton Police is manned 24/7, both AM and PM shift police vehicle with two officers tasked to work out of Picton. Vehicle will not always be there but Police are in attendance when the vehicle is there.

Invited the community to provide information, suspicious behaviours to police or ring crimestoppers.
